BOOK MANUSCRIPT

A Word Made Flesh: Disability and Editorship in U.S. Literature Culture

Historically, editorial work has been understood as mitigating error—whether catching misspellings or eliminating excessive turns of phrase. By contrast, my project unveils the often-invisible labor of editors who negotiate the embodied needs of writers and readers. As one of the first monographs to tether material text studies to disability studies, A Word Made Flesh reveals how publishing networks recover writing about disability without erasing marks of authors' impairments or access needs from the page.
